Please check the award from the following list for which the Facility or Company is being nominated:

**Collection System Operation and Maintenance Excellence Award** – this award recognizes a facility or company for demonstrating outstanding or extraordinary operation and maintenance of a wastewater collection system. After receiving the award, the system is not eligible for consideration for the next 4 years.

**George Parks Memorial Excellence in Public Relations Award** – this award recognizes an individual, Facility, Authority, Municipality, or Company who made significant accomplishments in promoting awareness and understanding of water environment issues among the general public. The facility or company must have at least one member of the EPWPCOA. After receiving the award, the member or the facility or company is not eligible for consideration for the next 3 years.

**Industrial Waste Pretreatment Program Award (EPA Program)** - this award recognizes facilities for excellence in development and administration of an Industrial Pretreatment Program. After receiving the award, the facility or company is not eligible for consideration for the next 4 years.

**Innovations Award** – this award recognizes an individual or facility who has demonstrated a unique and innovative approach to treating wastewater or solving a problem at the plant including collections systems. It must be something determined to be significantly different than standard practice or plant norms, and shown to be successful. Manufacturers and manufacturers’ representatives are not eligible for this award. After receiving the award, the member or facility is not eligible for consideration for the next 5 years.

**Joseph N. McKenna Memorial Service Award** – this award recognizes a company for technical and financial support of the EPWPCOA. After receiving the award, the company is not eligible for consideration for the next 4 years.

**Twila Dixon Memorial Laboratory Performance Excellence Award** – this award recognizes facilities for outstanding operation of a laboratory. After receiving the award, the facility is not eligible for consideration for the next 4 years.

**Plant Operation and Maintenance Excellence Award** – this award recognizes facilities for outstanding performance in operations and maintenance. After receiving the award, the facility is not eligible for consideration for the next 4 years.

**Safety - Collection System** – this award recognizes collection systems which have demonstrated excellence in the development and implementation of safety programs. After receiving the award, the facility is not eligible for consideration for the next 4 years. *Please be sure to complete and submit the appropriate Safety Application in addition to this form.*

**Safety - Facility Class I and Class II** – this award recognizes facilities which have demonstrated excellence in the development and implementation of safety programs. After receiving the award, the facility is not eligible for consideration for the next 4 years. *Please be sure to complete and submit the appropriate Safety Application in addition to this form.*
