A. E. "Bud" Fricker Memorial Award - this award recognizes outstanding service to the demonstrated outstanding service to the Association and the water pollution control field.

Bolenius-Weist Clean Streams Award – this award recognizes an individual who has demonstrated outstanding service to the development of operations excellence through individual contact and dedication to the water pollution control field.

Dan Treat Memorial Award - this award recognizes Plant Managers, Superintendents, Chief Plant Operators, or Shift Supervisors who have exhibited excellence in the management of wastewater treatment facilities. Category – Check One

Less than 2.0 MGD 2.0 MGD or more

David H. Schulte Memorial Award – this award recognizes an individual who has excelled in providing wastewater training and education.

George Parks Memorial Excellence in Public Relations Award – this award recognizes an Individual, Facility, Authority, Municipality, or Company who made significant accomplishments in promoting awareness and understanding of water environment issues among the general public. The facility or company must have at least one member of the EPWPCOA. After receiving the award, the member or the facility or company is not eligible for consideration for the next 3 years.

Innovations Award – this award recognizes an individual or facility who has demonstrated a unique and innovative approach to treating wastewater or solving a problem at the plant including collections systems. It must be something determined to be significantly different than standard practice or plant norms, and shown to be successful. Manufacturers and manufacturers' representatives are not eligible for this award. After receiving the award, the member or facility is not eligible for consideration for the next 5 years.

Ed Treat Memorial Leadership Award – this award recognizes an individual who has demonstrated leadership in the EPWPCOA and in the industry who also serves as a mentor or a model for others within the EPWPCOA.

Outstanding Employee of the Year – this award recognizes an exemplary employee at a wastewater treatment facility. Managers, superintendents, supervisors, and chief operators are excluded from consideration.
